ARTICLE I

The exact name of the corporation is:

ARTICLE II

The purpose of the corporation is to engage in the following business activities:

SAID ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCAT IONAL, AND SCIENTIFIC PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DI STRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER THE SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. THE BUSINESS ACTIVITY FOR SAID ORGANIZATION IS AS FOLLOWS: THE GOAL OF THE LEGAL PRIORITIES INSTITUTE IS TO DEVELOP AND PROMOTE RIGOROUS, SCIENTIFIC APPROACHES TO THE QUESTION OF HOW LEGAL RESEARCH ERS CAN DO THE MOST GOOD, BOTH BY IDENTIFYING THE MOST IMPORTANT, NEGLECTED, AND TRACTABLE PROBLEMS IN LEGAL RESEARCH, AS WELL AS CONDUCTING ACADEMIC CRESEARCH ON THE IDENTIFIED PROBLEMS.

NOTWITHSTANDING ANY OTHER PROVIS ION OF THIS DOCUMENT, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVIT IES NOT PERMITTED TO BE CARRIED ON (A) BY AN ORGANIZATION EXEMPT FROM FEDERA L INCOME TAX UNDER SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESP ONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR (B) BY AN ORGANIZATION, CO NTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C) (2) OF THE INTERNAL R EVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.
